Do Developers Run City Hall?

A report examining 2006 municipal election campaign contributions from developers to Ottawa city councillors and the mayor

Introductory remarks

This report, prepared by volunteers of Ecology Ottawa, is intended to offer its readers a small window into the world of campaign contributions at Ottawa City Hall. While reports focusing on political contributions made in Ottawa's muncipal elections have been completed before, we believe this is the first time a report of this nature has focused specifically on contributions from property developers, and their affiliated companies.

Do Developers Run City Hall? reveals how widespread the acceptance of political contributions from these influential vested interests is. All but six city councillors accepted money from developers in the 2006 municipal election. At least \$121,300 was donated by developers to winning council candidates and the mayor.

A similar, but far more detailed report published in 2009, which focused on the Greater Toronto Area, offers a clear explaination as to why the public and the media should pay close attention this important subject:

By far the largest component of corporate contributions to candidates and winning candidates in particular, comes from developers and the broader development industry... Development industry contributions are an extraordinary concentration of money from a single set of interests. Funding for candidates at the provincial and federal levels comes from a much more diverse group of industries and companies... Most developers are not major employers and even with the development related industry included, are not necessarily large components of overall economic activity, yet they contribute far out of proportion to any measure of their economic significance. Why is this? All development must pass through the municipal planning process during which developers and their planners work closely with city planning departments to fulfill or try to alter planning regulations and Official Plans.²

No one will argue that the influence wielded by developers in city planning has been the subject of heated debate in Ottawa recently. Last month, the Ontario Municipal Board ruled that Minto's plan for a huge subdivision in Manotick will proceed despite community and city council opposition. This month, council opted to hand over the redevelopment of Lansdowne Park to a select group of developers who submitted an unsolicited proposal, rather than pursuing an open, competitive process.

With the City of Ottawa currently engaged in an important update of its Official Plan, we felt it would serve the public interest to release this information in order to show one of the many avenues used by the property development industry to maintain a strong presence at city hall.

It is important to note that those that benefit from property development, urban growth and the construction required to build new communities are a diverse group of companies. As indicated in the 2009 MacDermid report:

The development industry includes a wide range of activities and companies. Not all have the same degree of interest in municipal development decisions. While the planning approval process is key to a developer' future profits, a contractor or building supply company's fortunes are tied to the industry as a whole rather than any particular development plan.

In the pages that follow contributions from "developers" have been limited to those companies and individuals directly involved in property development. We have tried to identify development related companies and individuals in the "Other interesting contributions" category. The process of identifying what form of business some companies and individuals are involved in was, at times, challenging.

As has been indicated in previous reports of a similar nature, there is a great need for reform within the municipal electoral campaign reporting mechanisms to ensure the public and the media can better identify who is contributing to the campaigns of our politicians. Perhaps this report will help motivate people to push for those changes.

Unless more light is shed on political donations and the other ways in which vested interests influence planning decisions taken at city hall, the shape of the Nation's Capital and how it grows could continue to head in its current environmentally and financially unsustainable direction.

Finally, we must of course acknowledge that developers and the city politicians who accept contributions from them are not "bad guys". Many development companies are family-owned businesses that contribute to the social fabric of the city, either by building sports fields for athletes to play on, or making donations to important charitable causes and building communities which people raise families in. But, for many Ottawans, lately it has appeared as if the vested interests have been prevailing over the broader public interest. And in these times of climate crisis, when urban sprawl leads to more personal vehicular traffic on our roads, more congestion, and more air pollution, we must all do better. We must build our cities far smarter, we must stop sprawl.

Development yes but only development that is sustainable.
