2	<b>Access points at new campus</b> (Bernie)	<ul style="list-style-type: none"> <li>Visuals used at the Nov. 13 Civic Hospital Neighbourhood Association AGM led to a conversation about access points</li> <li>Clarification: no decisions have been made on access points. The hospital isn't proposing an entrance across from Sherwood Drive. This assurance was disseminated earlier this year in partnership with City Councillor Jeff Leiper.</li> <li>Hospital will give a heads up to CEG when community presentations are planned so that members are aware of incoming feedback.</li> <li>The hospital will look at reworking visuals for the project to avoid giving the impression that access point decisions have been made. Renderings can give the impression of finality and we want to avoid this.</li> </ul>	<b>Update CEG on upcoming presentations (Sarah)</b>
3	<b>Narrative Follow up</b>	<ul style="list-style-type: none"> <li>Group is comfortable with the narrative as it stands now</li> <li>Emphasis that this is a living document and will continue to change as work continues.</li> </ul>

		<p>lifetime project, which is large and complex but carries real opportunities.</p> <ul style="list-style-type: none"> <li>• Rarely see this kind of engagement with volunteers so early in the process – very exciting.</li> <li>• Positive feedback from the Board about narrative – for the group’s consideration: consider the diagram and whether it should put community at the forefront; consider tweaking the third pillar wording on receiving public and providing care.</li> </ul> <p><b>Questions for Tony:</b></p> <ul style="list-style-type: none"> <li>• What’s the Master Planning Committee’s priority going forward? &gt;&gt; securing approval to move to the next phase</li> <li>• Size and composition of Master Planning Committee? &gt;&gt; not just board members but still fairly small group. Includes hospital CEO, reps from Foundation, Research, Heart Institute.</li> <li>• Are consultants lined up for next stage? &gt;&gt; Programmers and architects are still on contract for Stage 2. But not beyond that yet. No consultants lined up yet for series of studies to address zoning holding provisions.</li> <li>• Has nature of any P3 activities been scoped out? &gt;&gt; Not at this point. Guided by province later on.</li> <li>• Are there examples of similar projects elsewhere in the country / in the world that we can look to? &gt;&gt; Not many, if any. We have a very unique situation in Ottawa, with this site. Neighbourhood alongside heritage sites, pastoral next to urban landscape, balancing care with research and academics.</li> <li>• When will a fundraising campaign kick off? &gt;&gt; The Foundation is leading this and currently in the early ‘quiet’ phase – putting together a campaign cabinet with a chair from the community to lead it. Very early days.</li> </ul>	
5	<p><b>Community presentation updates</b></p>	<ul style="list-style-type: none"> <li>• Presented at Civic Hospital Neighbourhood Association AGM</li> <li>• Hospital has met with a representative from Safe Wings Ottawa to talk about bird-safe design</li> <li>• Hospital has met with Councillor Jeff Leiper to talk about cycling plans, both at the new campus and the existing campuses.</li> </ul>
